ACKNOWLEDGMENT OF RISK

In consideration of the right to attend and participate in the Program described above, the Ambassador (and, if the Ambassador is a minor, his or her parent or legal guardian) hereby:

1. Agrees to abide by all rules and regulations established by Southern Methodist University, and A-WOW World Summit (AWOW Inc.), and its service learning venues*;
2. Authorizes Southern Methodist University, the A-WOW World Summit, its service learning venues*, or any of its agents to provide, obtain, or authorize any reasonable incidental and/or emergency medical treatment for the Ambassador, in the event of the Ambassador illness, injury, or incapacity, and hereby accepts the responsibility to pay for such treatment;
3. Grants to Southern Methodist University and/or the A-WOW World Summit for any purpose connected with promoting the purposes and goals of Southern Methodist University and/or the A-WOW World Summit, but not for commercial exploitation, the right to use the Ambassador name, voice, and likeness in any writings, photographs, films, and recording of the Ambassador while he or she is participating in the Program, and any biographical information submitted by the Ambassador, and to use, reproduce, publish, and distribute the same;
4. Acknowledges that there is an element of risk involved in any activity involving travel outside of one's own home or community; certifies that the Ambassador is physically, mentally, and emotionally capable of attending and participating in the Program; assumes all risk of and financial responsibility for any loss or injury to the Ambassador or others that may occur as a result of the Ambassador negligence or misconduct; and indemnifies and holds harmless Southern Methodist University, the A-WOW World Summit, and service learning venues* from and against any and all costs, claims, demands, charges, liabilities, obligations, judgments, executions, costs of suit and actual attorneys' fees incurred or suffered by Southern Methodist University, the A-WOW World Summit, or service learning venues* as a result of, or rising out of, the Ambassador negligence or misconduct.

This consent and Acknowledgment of Risk shall not be amended, supplemented, or abrogated without the written consent of Southern Methodist University, the A-WOW World Summit and service learning venues*.

*Service Learning Venues for the purpose of this Consent refers to a site or sites defined by A-WOW Inc. where a group of Ambassadors is assigned for a portion of one day to experience some aspect of the Summit’s Projects or explore resources not readily available on campus.
