All media presentations should be no longer than 15 minutes and labeled with your name. Essays should be minimum 250, but no more than 500 words. Essays should be original and all references must be cited appropriately. Essays will be judged according to the following criteria:

- Creativity / Originality
- Understanding / knowledge of the subject
- Persuasive writing style
